

## NPI Updating or First-time Registration

For **NPI registration**, you will need:

- License Information: **LICENSE NUMBER** and **LICENSE EFFECTIVE DATE** (may also be listed at “Issue Date”). *If you do not have a license yet, you will add that later after your license is issued.*

To look up your Illinois license number and issuance date, go to the IDFPR website:

Or, you also should have received an email forwarded from GME with notification of your license information and instructions on how to view a printable copy of your license. (For more detailed information about looking up a printable copy of your license, see item “License Look Up” in your to-do list.)

- Departmental **Mail Code** and **Phone Number** – follow the [link](#) to an excel file where you should be able to locate the information for your program. If the information is not populated, contact your program administrator for the correct information.

Once you have the above information ready:

1. Go to <https://nppes.cms.hhs.gov/#/>
2. If you are already registered, but need to recover your User ID and/or password, follow the appropriate link, go through all of the prompts, and log out of the password recovery system.
3. If this is your first time registering, follow prompts to first create your user ID and password for the NPPES system, then log out of the identity creation system.

### Create a New Account

You need an Identity & Access Management System (I&A) User ID and Password to create an account.

**Individual Providers, Organization Providers, Users working on behalf of an organization**

If you don't have an I&A account, need to update your existing I&A account, or need to recover your User ID or Password, select the CREATE or MANAGE AN ACCOUNT button.

Once you have successfully created your I&A account, your existing Type of Provider will be maintained with your I&A account.

After successfully creating your I&A account, return to NPPES and use your User ID and Password to log into NPPES where you can create and maintain the NPI for your provider(s).


